STENOGRAPHER RECRUITMENT EXAMINATION, 2025

NOTICE

The final result for appointment to the post of Stenographer under Advertisement No. PHC/02/2025 for Stenographer Recruitment Examination, 2025 is being published alongwith this notice for information to all concerned. The candidates must take notice of following facts which have been taken into consideration for preparation of final result:

1. Total 210 candidates who had secured the minimum qualifying standard in the Computer Based Written Test comprising English Shorthand Computer Typing Test, Multiple Choice Question based Objective Test and English Typing Test as prescribed in the clause 7(i), (ii) & (iii) of the Advertisement No. PHC/02/2025 were called for appearing in the interview. Out of them, 203 candidates appeared, while 7 remained absent from the Interview.
2. During Document Verification, there were a total of 11 candidates who were either unable to produce the required NCL Certificate to substantiate their claim of category in the application form, as per the terms and conditions specified in the advertisement or had entered wrong category in their application form. All such candidates were re-assessed as per the correct details under Unreserved Category at each stage from the initial stage of the recruitment exercise. Upon their re-assessment, 7 candidates could not qualify at the Written Test. Consequently, their earlier selection in the Written Test has been cancelled. The list of such candidates is provided at **Annexure-II**.
3. Finally, only 196 candidates who had qualified at all stages of examination have been considered for preparation of final result.
4. The marks obtained by a candidate in the Written Test and Interview have been taken into consideration for preparation of final result.

5. If two or more candidates have secured equal marks, the candidate securing higher marks in the written test have been placed above and if the marks obtained in the written test are also equal, then the candidate born earlier have been placed above in the merit while preparing final result.
6. In cases, where everything was found equal, the selection has been made by granting preference to the candidates having NCC-B certificate or who have served in the Territorial Army.
7. Candidates securing marks equal and above the cut-off marks of Unreserved Category have been placed in the Unreserved Category while other candidates have been placed in their respective category of reservation.
8. The names of these 196 candidates in order of merit shall form a panel for this recruitment exercise, which shall be valid for a period of one year.
9. The category wise advertised vacancy was as follows:

Out of total 111 (43 Backlog) vacant posts, 03 (Three) posts shall be horizontally reserved for orthopedically handicapped (OH) candidates.

Additionally, 3 (three) posts of Stenographer have been created in the establishment of the Patna High Court and by the order of Hon'ble Court, they are also to be filled up in the instant exercise, as such, the aforesaid advertised vacancy has been increased by 3 (three) posts.

As per reservation roster applicable to the instant recruitment exercise, 1 seat each will go to BC Category and EWS Category respectively and the last 1 seat will go to EBC-Female Category.

The updated breakup of vacancy is as under:

However, during the processing of result, it was found that no candidate had qualified under OH category. As such, in view of resolution of the Government of Bihar, 3* (three) posts from Unreserved Category are to be earmarked, kept vacant and carried forward to the next recruitment exercise. As such, selection in Unreserved Category have been made on 29 posts only.

10. The names of selected candidates are in order of merit in the result and their category of selection is indicated against their respective names at **Annexure-I**.
11. Wherever required, the deficit of female candidates, as per above vacancy, has been met by replacing equal number of male candidates from the respective category.
12. The result comprises 88 candidates, in UR Category all 29 seats have been filled and female quota has also been met, in EWS Category all 7 seats have been filled and female quota has also been met by replacement, in BC Category all 16 seats have been filled and female quota has also been met, in EBC Category all 27 seats have been filled but female quota could not be met due to unavailability of qualified candidates, in SC Category only 9 seats have been filled due to unavailability of qualified candidates in requisite number. No candidate has qualified under ST and OH Category.

13. The Cut-Off marks for each category is as follows:

14. Cut-Off marks for those categories have not been given/shown, where, either the required number of qualified candidates were not available or no replacement was done to meet the requirement of female candidates in any particular category.
15. Candidature of all those candidates against whom any police case/complaint case is pending, shall be provisional subject to final outcome of the respective cases pending against them.
16. Appointment Letters of selected candidates shall follow through Speed Post/Registered Post.
